Good afternoon residents, family and guardians,

Today the National guard was here to conduct yet another round of COVID-19 testing. It is our hope that we end up with all negative test results and we can clear our outbreak status that began on 10.23.2020.

Yesterday, the Guardians and DPOA's of those residents whom have been activated for making medical decisions for the residents, were sent via USPS a:

- Vaccine Administration Record (VAR)
- Informed Consent for Vaccination in Long Term Care Facility (LTCF) form from Walgreens

Please complete this form and return it to the facility either by USPS or drop off by Saturday, December 26th as we are scheduled to have our first COVID-19 vaccine administered on 12.29.2020. Our second step vaccine will take place on 1.19.2021.

All staff at St. Ann will also be offered the vaccination this same day. While we cannot mandate that the staff receive this vaccine, we are strongly encouraging each of them to consider taking this vaccine, just as we have with the flu vaccine to safeguard themselves, their families, and those whom are in our care.
